## **Regulatory Norms for Admissions**

B.A., LL.B. / B.B.A., LL.B. 5 Years Integrated Degree Course. & LL.B. 3 Years Degree Course.

#### **Eligibility Criteria:**

Selection will be based on merit cum reservation basis, An applicant who has successfully completed regular Pre-University Course or Senior Secondary School Course with (10+2 Pattern) from an Institution recognized by the Central or State Government in India or any equivalent Institution from a Foreign University recognized by the Government of that country and also recognized in India may apply for 5 years integrated degree course in law leading to the conferment of Degree in B.A., LL.B. / B.B.A., LL.B. upon successful completion of the regular programme conducted under these regulation. An applicant who has successfully graduated in any discipline with a minimum of 45% from any University established by an Act of Parliament or by a State Legislature or an equivalent National Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence may apply for 3 years degree course in law leading to the conferment of Degree in LL.B. upon successful completion of the regular programme conducted under these regulation.

#### **Curriculum:**

Candidates seeking admission to B.A., LL.B. / B.B.A., LL.B. 5 Years Integrated Degree Course will have 10 semesters course spread over a period of 5 years and LL.B. 3 Years Degree Course will have 6 semesters course spread over a period of 3 years. \*The Applicant who passed the prescribed qualifying Examination f rom recognized boards of Examination that are situated outside of Karnataka or in foreigner Country shall compulsory obtain the ELIGIBILITY CERTIFICATE before taking admission.
