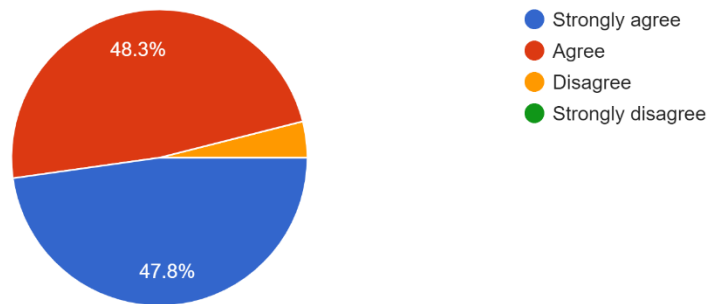

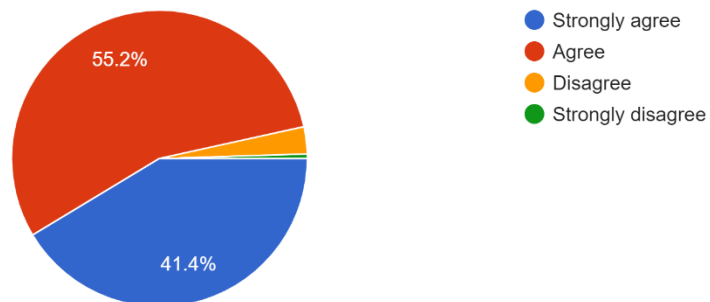

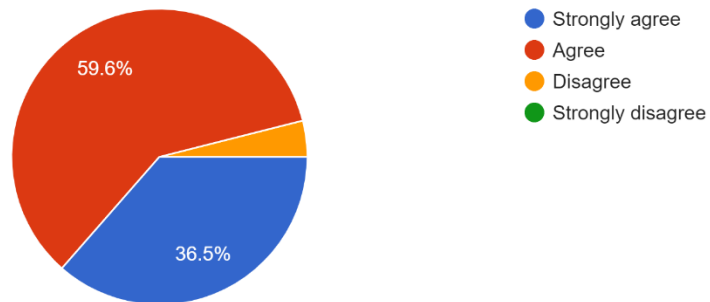

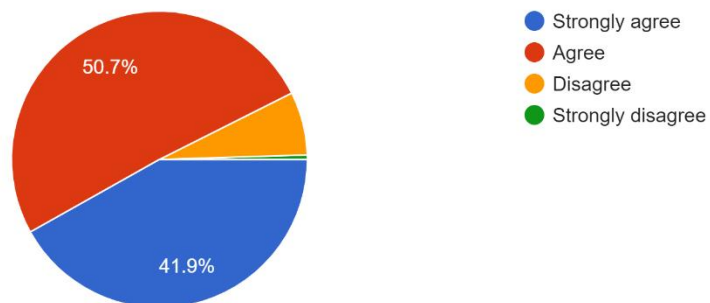
Do you think the curriculum provided the right knowledge of theoretical and practical experience?

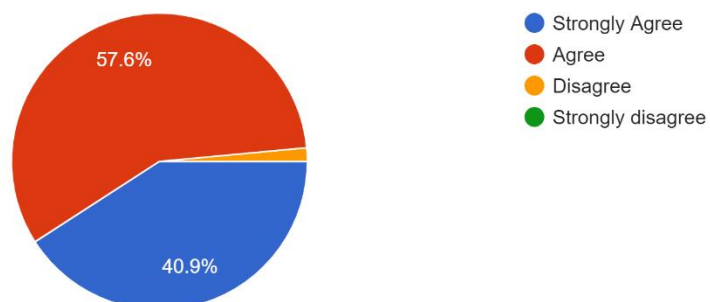
Curriculum satisfies the industry requirements and has provisions for professional development

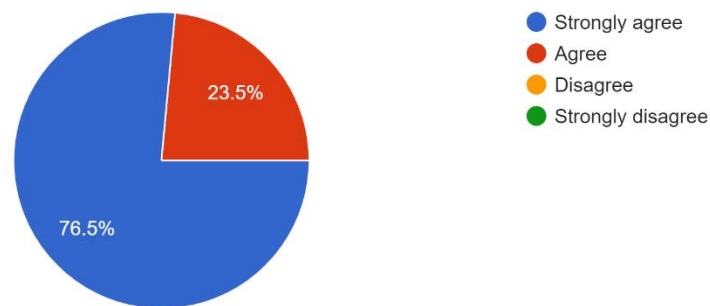
TEACHERS FEEDBACK REPORT

Feedback on various aspects of curriculum is sought from -faculty members of oxford college of pharmacy. The aspects such as provision of adequate time and resources for framing syllabus,

coverage of both theoretical and practical components in the syllabus, the coherence of the syllabus with Programme Outcomes, involvement of the field experts while designing the syllabus, focus on necessary technical/ teaching skills, ensuring components that inculcate ethical values, enlisting reference books, focus on flexible curriculum based on current trends, updated elective courses etc. As teachers play a pivotal role in designing and implementing the curriculum, the inputs received from their feedback was taken into consideration for further necessary action wherever applicable. Majority of the teachers are agreed that aim and objective are well-defined to teacher. 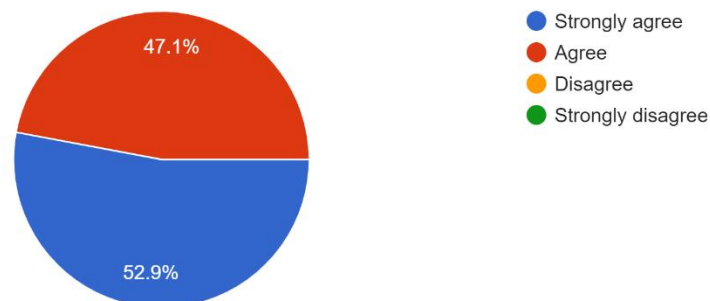

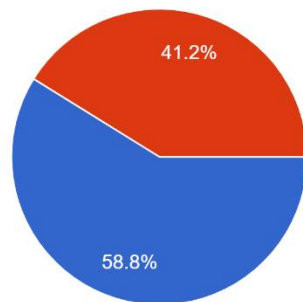
Pedagogy proposed in the curriculum matches the contents

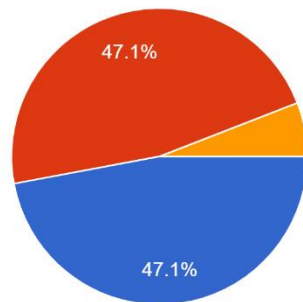

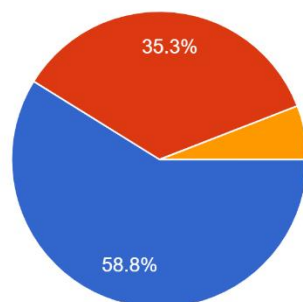

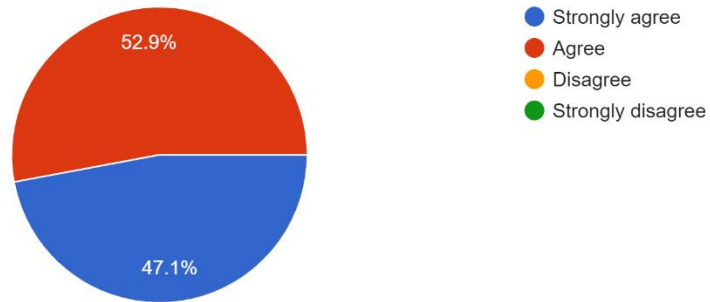

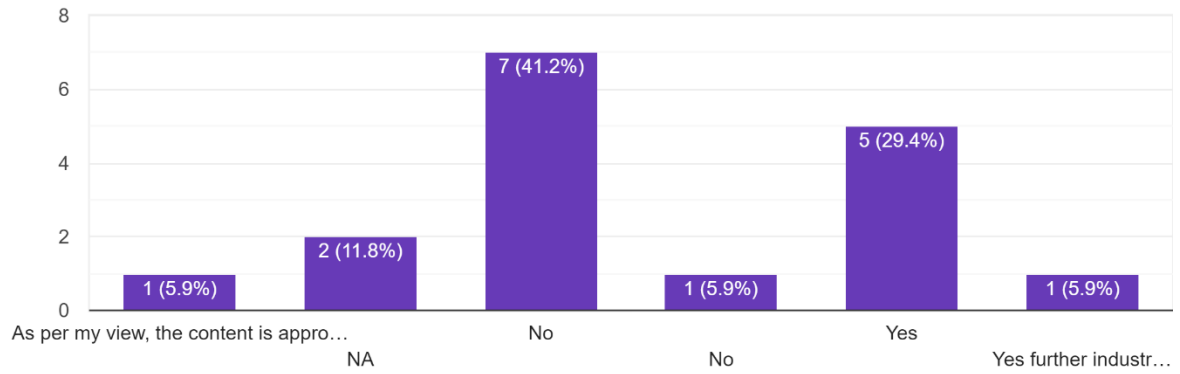
Whether the framed syllabus is related to the subjects?

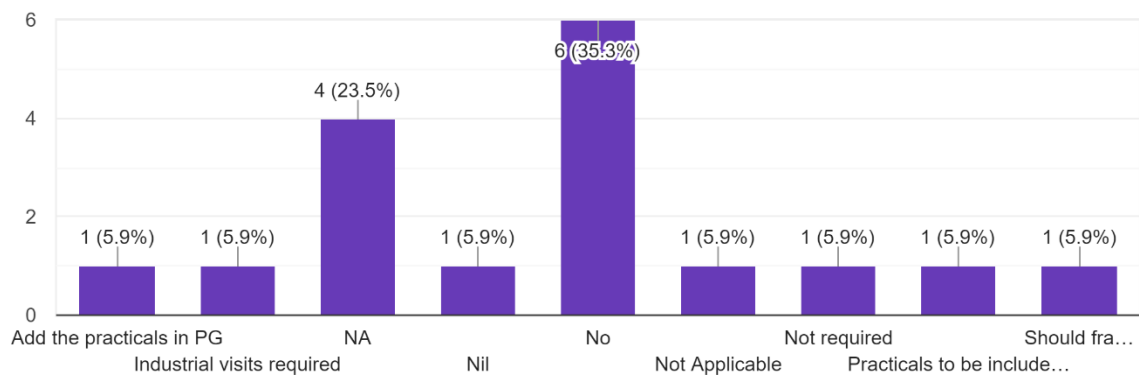

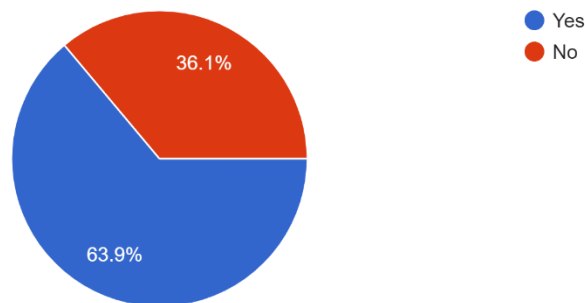


ALUMNI FEEDBACK REPORT

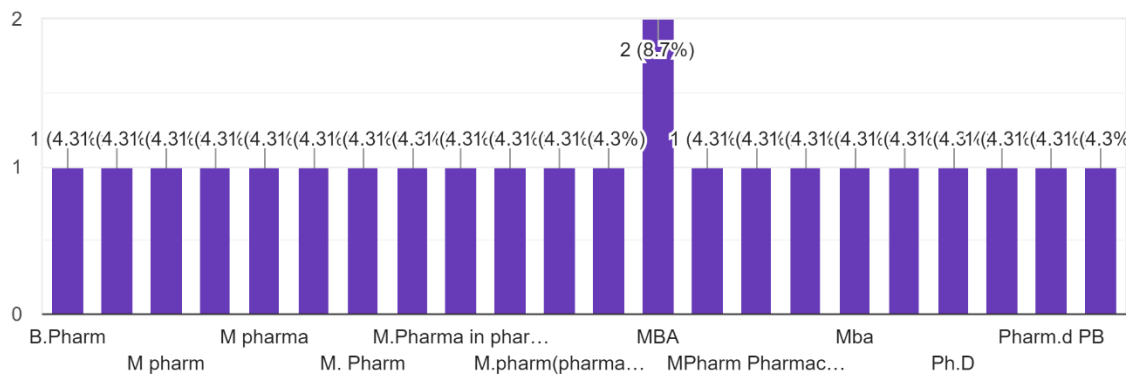

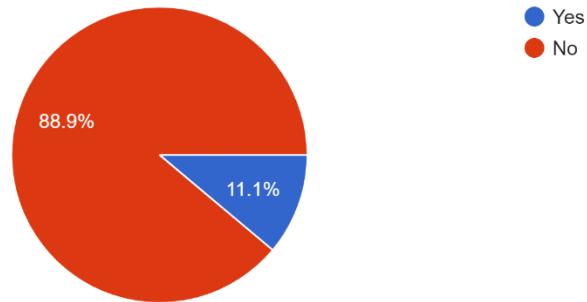

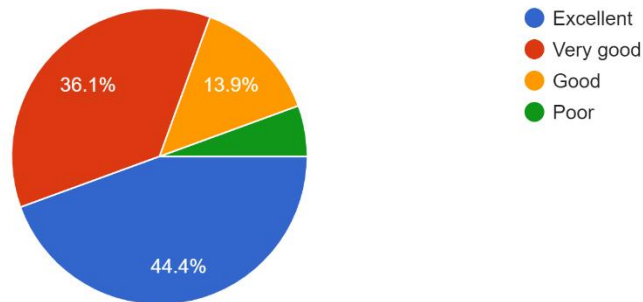

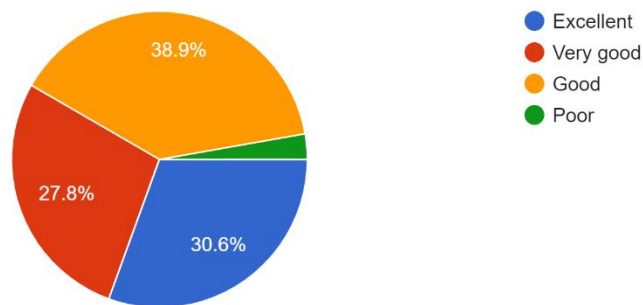

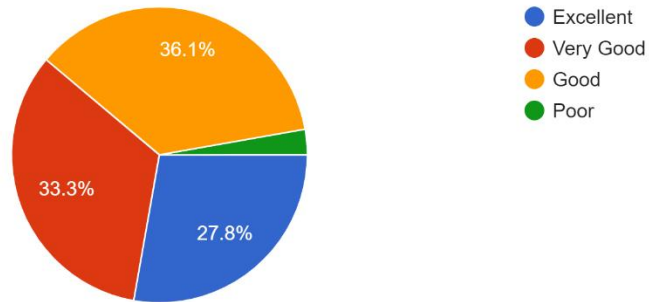
Overall academic atmosphere in the college

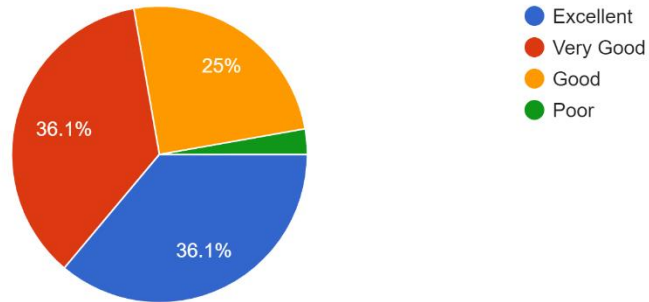

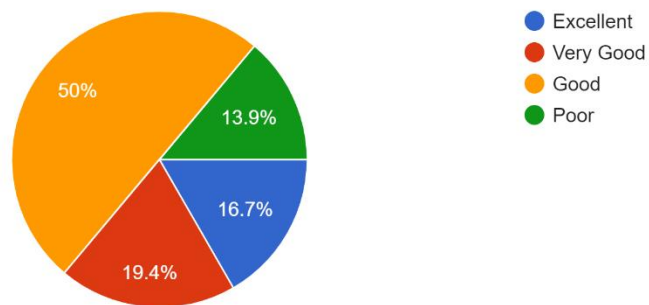

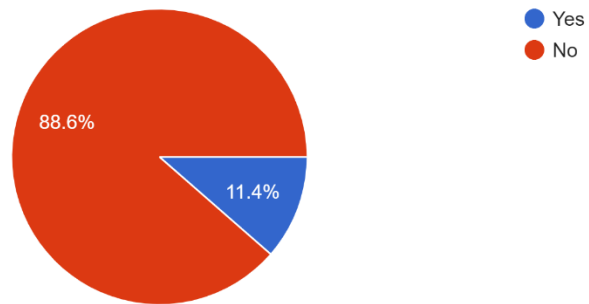

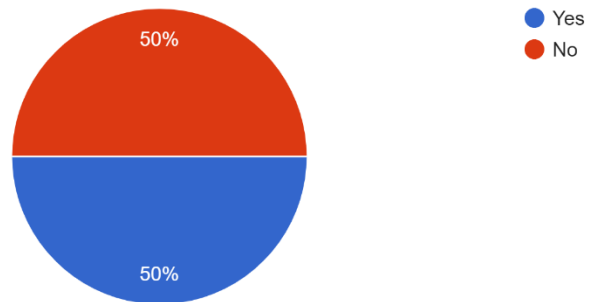
