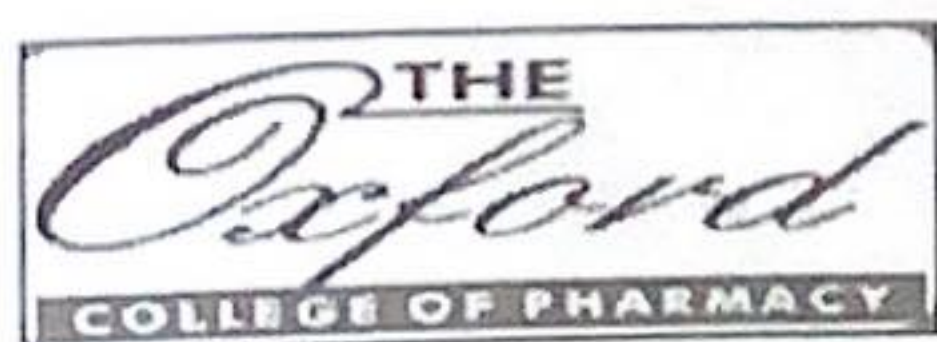

- Chairperson informed the teachers to instruct the students to follow the rules and regulation regarding the same.

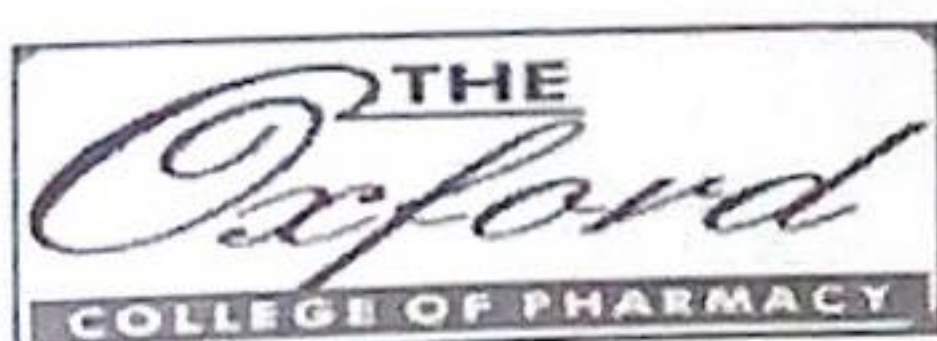
