NOTIFICATION

Whereas the Indian Nursing Council in its Circular/Order F. No. 22-10/2015-INC(AR) dated: 22-05-2015 has directed all the Nursing Colleges to step up Anti Ragging Mechanism in order to achieve the objective of making the Nursing Colleges/Institutions "Ragging Free Zone" by adopting and enforcing the measures envisaged in the letter and also following the UGC Regulations, 2009.
