Some common forms of IPR includes patents, copyrights, trademarks, and trade secrets. One can go for registering the IPR, he or she can protect the ideas from infringement and ensure that you have the legal authority on your inventions. Additionally, IPR plays a vital role in nurturing innovation, creativity and economic development. IPR encourages inventors with incentive to invest time, effort and resources in developing new ideas and products so thereby which they can get the benefits of their inventions. It prevents unauthorised use, reproduction or distribution of the inventions by others. IPR promotes research and development by providing protection to new technologies, and advancements in research. Additionally, IPR enhances competitiveness of businesses by offering protection to brands, innovations, trade secrets thereby enabling differentiation between themselves in the market and maintaining competitive environment.

Through copyrights and IPR, cultural works, traditions etc., can be protected thereby which cultural heritage can be preserved and further ensures that inventors receive recognition for their contributions. Overall IPR are essential for promotion of creativity, protecting investments in innovation, innovations and thereby acts as a driving force for societal progress.
